- The Principal hereby agrees that the present General Conditions shall apply to any order placed either verbally or in writing even though no reference to these General Conditions has been made.
- The award of your shipment/s to GENESIS LOGISTICS implies acceptance by the Principal of this offer and agreement to the Terms & Conditions set forth in the same.
- GENESIS LOGISTICS reserves the right to select the service providers of its choice, unless otherwise stipulated
- The Principal bears full responsibility for providing correct information. Any incorrect information provided
 that results in damages of what-so-ever nature such as, but not limited to: fines, penalties or sanctions
 imposed by the authorities, will be borne by the Principal.
- Fees for Warehousing, Storage, Detention, Demurrage and whatever other costs incurred due to reasons beyond GENESIS LOGISTICS' control will be borne by the Principal.

The weight/volume ratio applicable for airfreight is (1:6) or 1M3 = 167 Kgs
- Important Condition for Ocean freight: The tariffs do not apply for dangerous goods cargoes (I.M.O / I.M.D.G), perishables, oversize and heavy cargoes, personal effects, livestock, animals, human remains and high value cargoes unless otherwise specified. Our ocean freight tariffs do not include port installation charges, port handling charges, wharfage costs, warehousing transfer and storage fees unless specifically indicated in our offer.
